The Uchch Shiksha Anubhag-1 is administratively concerned with the said Adhiniyam.

THE UTTAR PRADESH PRIVATE UNIVERSITIES (SIXTH AMENDMENT)

ACT, 2024

(U.P. ACT No. 19 OF 2024)

[As passed by the Uttar Pradesh Legislature]

AN

ACT

further to amend the Uttar Pradesh Private Universities Act, 2019.

IT IS HEREBY enacted in the Seventy-fifth Year of the Republic of India as follows:-

1. (1) This Act may be called the Uttar Pradesh Private Universities (Sixth Amendment) Act, 2024. Short title and commencement

(2) It shall be deemed to have come into force with effect from the 14th day of October, 2024.

2. In Schedule 2 of the Uttar Pradesh Private Universities Act, 2019 (hereinafter referred to as the "principal Act") after serial no. 45, the following serial number along with the entries relating thereto shall column-wise be inserted, namely:- Amendment of Schedule 2 of U.P. Act no. 12 of 2019

3. (1) The State Government may, for the purposes of removing any difficulty in relation to the establishment of "Vidya University, Meerut", Uttar Pradesh by order published in the *Gazette*, direct that the provisions of the principal Act shall during such period, as may be specified in the order, have effect subject to such adaptations, whether by way of modification, addition or omission, as it may deem necessary or expedient : Power to remove difficulties

Provided that no such order shall be made after two years from the date of commencement of this Act.

(2) Every order made under sub-section (1) shall be laid before both Houses of the State Legislature, as soon as may be after it is made.

Repeal and saving

4. (1) The Uttar Pradesh Private Universities (Eighth Amendment) Ordinance, 2024 is hereby repealed.

U.P. Ordinance no. 16 of 2024

(2) Notwithstanding such repeal, anything done or any action taken under the provisions of the principal Act as amended by the Ordinance referred to in sub-section (1) shall be deemed to have been done or taken under the corresponding provisions of the principal Act as amended by this Act as if the provisions of this Act were in force at all material times.

STATEMENT OF OBJECTS AND REASONS

The Uttar Pradesh Private Universities Act, 2019 (U. P. Act no. 12 of 2019) has been enacted to provide for the establishment of new Private Universities and incorporation of existing Private Universities in the State of Uttar Pradesh for imparting higher education and to regulate their functions and for matters connected therewith or incidental thereto.

In order to provide for the establishment of a new Private University namely, Vidya University, Meerut, Uttar Pradesh, it was decided to amend Schedule 2 of the aforesaid Act.

Since the State Legislature was not in session and immediate legislative action was necessary to implement the aforesaid decision, the Uttar Pradesh Private Universities (Eighth Amendment) Ordinance, 2024 (U.P. Ordinance no.16 of 2024) was promulgated by the Governor on October 14, 2024.

This Bill is introduced to replace the aforesaid Ordinance.
