NRC/NCTE/F-7/2007/14454-59 dated 23.02.2007 followed by revised recognition order of two-year duration with an annual intake of 100 seats was issued to the institution vide order dated 10.06.2015.

- 2. AND WHEREAS, the recognition was also granted to the institution for conducting D.El.Ed. course of two-year duration with an annual intake 50 students vide order No. F. No. NRC/NCTE/NRCAPP-949/233rd Meeting/89869-924 dated 03.03.2015 followed by recognition for an additional annual intake of 50 students vide order dated 03.03.2016 thus making total annual intake of 50+50=100 students.
